

SPRINGDALE TOWNSHIP WINTER SNOW TOWING CONTRACT

This agreement made the 18 day of February, 2021, by and between:

TOWNSHIP OF SPRINGDALE (hereinafter referred to as "TOWNSHIP") with its principal place of business located at 100 Plate Road, Harwick, PA 15049

AND

RON GILLETTE, INC. (hereinafter referred to as "GILLETTE") with principal place of business located at 900 Olive Avenue, Natrona Heights, PA 15066, PA salver license 0317.

The parties hereto intending to be legally bound hereby agree as follows:

1. For a period of two (2) years commencing at the signing of this contract, GILLETTE hereby agree to provide towing services during winter snow events to individuals requiring such service in the Township of Springdale under the following rates which shall be charged to and collected from the owner of the vehicle:

1. Towing	\$150.00 regular tow/\$175.00 flat bed
2. Towing (Holiday, overtime, wknd)	\$225.00/\$250 flat bed
3. Milage	\$6.00/per mile regular work day/\$8.00 other times. (Holiday, overtime, wknd)
4. Outside Storage	\$50.00/per day
5. Inside Storage	\$75.00/per day
2. GILLETTE hereby agree to provide TOWNSHIP with a Workman's Compensation Insurance Certificate, and a Certificate of Public Liability Insurance in the amount of Five Hundred Thousand Dollars (\$500,000) property damage and One Million Dollars (\$1,000,000) General liability coverage, and One Hundred Thousand (\$100,000) per person per accident to cover all work and operations in connection with this contract. The insurance provided shall include both vehicles as well as a storage yard, and TOWNSHIP shall be named as an additional insured on said insurance. GILLETTE shall submit the required Certificates of Insurance within fifteen (15) days of the execution of this contract.
3. Following the execution of this contract, any request for a change in the terms of the


contract shall be in writing. Any approval or disapproval of the request shall also be in writing.


4. GILLETTE shall indemnify and save TOWNSHIP harmless from any loss, personal injury, death, or other damage that may be incurred as a result of entering into this contract.
5. The Township reserves the right to terminate the contract if the performance of GILLETTE is not acceptable to TOWNSHIP. TOWNSHIP shall provide fifteen (15) days written notice of the contract termination.
6. All notices and inquiries concerning this contract shall be addressed to the President of the Board of Commissioners, during regular business hours. GILLETTE shall furnish TOWNSHIP on a monthly basis any complaints from any person who has had their vehicle towed or stored. The reports shall include the name and address of the person who made the complaint, the date of the tow or storage, the nature of the complaint, and the response by the tow to the person's complaint.


