ORDINANCE NO. 49

AN ORDINANCE OF THE TOWNSHIP OF SPRINGDALE, ALLEGHENY COUNTY, PENNSYLVANIA, ENACTING FIXING AND LEVYING THE REAL ESTATE TAX RATE WITHIN THE TOWNSHIP OF SPRINGDALE FOR THE YEAR 2022 AT A RATE OF 6.5 MILLS.

WHEREAS, Council for the Township of Springdale has adopted a final budget for the year 2022; and

WHEREAS, The Township of Springdale Board of Commissioners is required to fix and levy real estate tax rate for the year 2022, in accordance with the adopted budget.

BE IT ORDAINED AND ENACTED, and it is hereby ordained and enacted by the Board of Commissioners of the Township of Springdale, County of Allegheny, and Commonwealth of Pennsylvania, that a tax be, and the same is hereby, levied on all real property within the said Township subject to taxation for the Fiscal Year 2022, as follows:

SECTION 1. A tax is hereby fixed and levied for the fiscal year 2022 as follows:

Tax rate for general purposes, the sum of:

6.5 mills

On each dollar of assessed valuation, or the sup of: on each one hundred dollars of assessed valuation.

65 cents

The same being summarized in tabular form as follows:

Mills on each dollar of assessed valuation

Cents on each one hundred dollars of assessed valuation

Tax rate for general purposes:

6.5 Mills

.65 cents

Total:

6.5 Mills

.65 cents

SECTION 2. The final budget for the year 2022, as approved by the Township Board of Commissioners, is incorporated herein as though fully set forth at length.

SECTION 3. Any Ordinance or any part of any Ordinance conflicting with any of the provisions of this Ordinance are hereby repealed insofar as the same effects this Ordinance.

SECTION 4. If any sentence, clause, section, or part of this Ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality, or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections or parts of this Ordinance. It is hereby declared as the intent of the Township that this Ordinance would have been adopted had such unconstitutional, illegal or invalid sentence, clause, section or part thereof not been included herein.
